Wee Miss (0-12 months), Baby Miss (13-23 months), Toddler Miss (2-3 yrs),  
Mini Miss (4-5 yrs), Young Miss (6-7 yrs), Petite Miss (8-9 yrs), Preteen Miss (10-12 yrs),  
Teen Miss (13-15 yrs), Miss (16-19 yrs), Elegant Ms (20 yrs & Up, Married or Unmarried)

### **Wee Baby- Preteen Miss: Mandatory Events are Gown and Casual Wear \$45**

**Gown:** All age groups will model a gown of their choice. Any style is acceptable-may be Glitzy, Plain, Flower girl, etc. Contestants in Wee Baby-Petite may wear a long or short gown. All other age groups must wear a long gown.

**Casual Wear:** Contestants will wear a casual wear. This can be anything really off the rack or custom made. Limited stones and sequins if you bought an outfit that has sequins or stones then that's fine, but we are not looking for glitzy attire. No face paint or mask allowed. No props. We will provide upbeat music.

**ALL CONTESTANTS WILL RECEIVE A GIFT!**

**Teen Miss, Miss, and Elegant Ms: Mandatory Events: Gown, Casual Wear, and Interview for Divisions - \$55**

**Gown:** All contestants in these divisions MUST wear a long gown of their choice. Gown must be age appropriate and tasteful. There will be an on-stage question during gown.

**Casual Wear:** Contestants will wear a casual wear. This can be anything really off the rack or custom made. Limited stones and sequins if you bought an outfit that has sequins or stones then that's fine, but we are not looking for glitzy attire. No face paint or mask allowed. No props. We will provide upbeat music.

**Interview:** Contestants may wear a dress, pants suit, or business/interview suit. Each contestant will have five (5) minute panel style interview.

**Photogenic- ALL AGE GROUPS \$5:** Submitted photos should be age appropriate and may be Natural or Re-touched moderately. Pictures may be B&W or color and should be at least 8x10 in size. Each additional photo is \$5.00 each. You may enter as many pictures as you like, with the highest score considered for the Age Division Photogenic award.

Rules and Regulations

1. ABSOLUTELY NO ENTRIES WILL BE TAKEN AT THE DOOR!!!
2. Hair and Makeup:
  - a. Extensions may be used, but no other hair pieces (no falls, wiglets, etc.), hair should look soft and pretty, no big, stiff pageant hair. Your child does not have to wear extensions to win.
  - b. Light, natural tanning is allowed; however, your child should not look orange or dirty. Your child does not have to be tanned to win.
  - c. No Flippers!
  - d. False eye lashes are allowed on Teen Miss, Miss, and Elegant Ms contestants ONLY.
  - e. Make-up—these are rules to be followed, but remember, NO AGE MUST WEAR MAKEUP. Makeup is not a requirement to win.
    - i. Wee Miss (0-12 months) and Baby Miss (13-23 months)- NO MAKEUP and contestants will be checked in group lineup.

- ii. Toddler Miss (2-3 yrs) are allowed light face powder, light blush and lip gloss, ONLY. No foundation, no eye shadow, no eye liner, no lip liner, and no colored lip stick.
  - iii. Mini Miss (4-5 yrs) and up are allowed LIGHT, age appropriate makeup. Make up should look natural and enhance the contestant's natural beauty.
3. Modeling- NO PRO-AM MODELING ROUTINES, however modeling should be upbeat, peppy and fun! Wee Miss and Baby Miss will NOT be scored on modeling, but personality will weigh heavy. All other ages, 2 and up will be scored on modeling ability and personality for their age. It is acceptable for an adult to go on stage with a contestant up through age 3. Ages 4-5 may have coaching assistance from behind the judges, however all ages 4 & up should be able to model on stage without an adult on stage. If circumstances require an adult, contact me personally and we can discuss.
  4. Stage will be a front "T" (3 "X"s on the front and 1 "X" on the runway).
  5. If age is questioned, contestant must be prepared to show birth certificate for proof of age.
  6. There will be a posted group line up in gown and casual wear.
  7. Groups will be called to line up. If contestant isn't in lineup, ready to go when called individually, contestant will take an automatic 10-point deduction off total score for that event.
  8. Please do not ask who or how many is in your age division, as this information changes constantly. This information will be posted on the event page on Facebook the week before the pageant.
  9. No personal checks will be accepted at all! Cash only at the door! Sorry, no exceptions!!
  10. Director will not combine age divisions for any reason.
  11. We run a fair and honest pageant system. All contestants will compete on an equal basis. Our judges will be well qualified to judge your child. All judges' decisions are FINAL!
  12. **ALL QUEENS ARE REQUIRED TO PARTICIPATE IN EVENTS DURING THE FAIR AND DURING THE YEAR**
  13. **Unsportsmanlike conduct will not be tolerated. Any complaints against an individual in the audience, contestant, or chaperone of contestant will be asked to leave and will not be permitted re-entrance.**
  14. **THE WINNER OF THE MISS DIVISION WILL BE OBLIGATED TO COMPETE AT THE MISS VIRGINIA ASSOCIATION OF FAIRS PAGEANT IN JANUARY OF 2019.**
